## KAISER COMMISSION ON MEDICAID, SCHIP AND THE IMPACTS ON STATE ECONOMIES

Medicaid is the nation's largest major public health benefit for those who are low income including low income children and Medicare beneficiaries. As state policymakers, elected officials and legislators deal with budget shortfalls, many states look to Medicaid and SCHIP for savings. The Kaiser Commission reports that cutting Medicaid not only adversely impacts the beneficiaries and providers, but also has an impact on the economy of a state.

#### **Key Study Findings:**

# Medicaid spending generates economic activity, including jobs, income and state tax revenue, at the state level

- Medicaid is the second largest line item in state budgets
- Medicaid is the largest source of federal funds for states
- Federal matching dollars support jobs and generate income within the health care system and throughout other parts of the economy

#### The economic impact of Medicaid spending varies state to state

- Medicaid spending has a positive impact on state economies
- The magnitude of the impact is dependent on state Medicaid spending, a state's matching rate (FMAP) and the economic multipliers
- States and state regions/counties that rely more on public services and the health care industry may be disproportionally affected

#### Reductions in state and federal Medicaid leads to declines in economic activity at the state level

- Reductions in state spending automatically reduce the infusion of federal dollars to a state.
- Decreases in funding reduce the flow of dollars to hospitals, nursing homes, home health agencies, and pharmacies, and reduce the amount of money circulating through the economy of a state, affecting employment, income, state tax revenue and economic output.

The length of this economic crisis in our nation and states, pending legislation and federal regulations, and the availability of federal relief will play a major role in how Medicaid programs and the individuals served are impacted by this downturn as well as the economy of states.

**Maine Primary Care Association** The Maine Primary Care Association developed elementary and middle/high school MaineCare Medicaid posters to post directly into the schools before the kids returned to school. The posters were targeted to parents and they sent three poster to every school principal in Maine with suggestions on where to post them. The principals sent them to the nurses and as a result the Maine Primary Care Association received multiple requests to come and give trainings on MaineCare. This effort also helped with doing the citizenship and identity documentation outreach for Medicaid. It brought into the fold all the people who have direct contact with kids and were in a position to help get the kids documented. Another benefit was the regular flow of messages from the nurses if they had a question about MaineCare and helping with enrollment. The posters were so popular all of their health centers asked for them to put up in all patient rooms for this year's back-toschool and community health center week. ## Did You Know?

A one percent rise in the nation's unemployment rate is projected to lead to \$1.1 million additional uninsured and 1 million new Medicaid enrollees (600,000 children and 400,000 adults). This will increase state expenditures in Medicaid spending by \$1.4 billion while tax revenues fall by 3 to 4 percent according to the
