## COST SHIFTING TO STATES

Georgetown University's *Center for Children and Families* January 2008 newsletter highlights federal and state policy issues affecting children's health, including looking back at SCHIP in 2007 and looking forward towards 2008. In addition, the report covers the administration rule changes to Medicaid which will have far reaching consequences for low-income individuals.

Rulemaking to enact policy changes previously rejected by Congress is how the Administration is getting congressional enactments such as the DRA (Deficit Reduction Act of 2005) and the CMS Directive of 8/17/07. Costs are being shifted onto states and their already overburdened healthcare systems. These changes will impact critical healthcare access and services.

In reviewing the six new Medicaid regulations which change long-standing rules, it is estimated that they could result in a \$50B reduction in federal Medicaid spending over the next five years. This cost shifting would impact states ability to maintain services or expand coverage. John Dingell (D-Mich) and Tim Murphy (R-PA) have introduced legislation (HR5613) to place a one-year moratorium on the Medicaid regulations. A bipartisan group of senators (Edward Kennedy, D-Mass, John Rockefeller, D-W.VA, Olympia Snowe, R-Maine) also introduced a bill (S2819) to block the Medicaid regulations, including the 8/17 SCHIP Directive. Attention must be focused on educating the community and decision-makers on the impact the directive will have on families enrolled in SCHIP and Medicaid-funded programs.



## WHAT'S UP WITH THE NETWORK

The National Covering Kids and Families network continues to grow with new member organizations and individuals joining every month. The efforts of the Membership Committee and network members are applauded for growing our network!

Currently the NCKF network represents over 31 states, 73 or-
