STATE BUDGETS AND MEDICALD

Medicaid covered over 60.5 million people in 2007, including over 29.5 million children, according to the Center for Children and Families May 2008 report on *Medicaid and State Budgets: Looking at the Facts*. Medicaid is the largest source of healthcare coverage in the United States. The majority of costs for elderly, disabled and 50% of all nursing home care is financed by Medicaid.

Medicaid's impact on state budgets is often misunderstood by state legislators. It is important to distinguish between total spending, which includes federal dollars, and state spending. The positive impact of the federal share of Medicaid funds on the ability of a state to finance other priorities is also not clearly understood.

The National Association of State Budget Officers (NASBO) shows how states spend their funds and the various ways Medicaid can impact state budgets. It is important to define whether these numbers are the total expenditures or state general fund and federal dollars.

Misunderstandings by state legislators of Medicaid's impact on state budgets and priorities can provide less than positive discussions about the value of Medicaid. Misleading information can lead legislators to make decisions that can be harmful to Medicaid's ability to provide necessary healthcare for the uninsured and underserved. Outcomes from the meeting included: (1) Further defining the NCKF Network's national niche; (2) Building a sustainability plan, including voting to have CHC continue as administrative lead; (3) Strengthening SCHIP reauthorization strategy; and (4) Improving operating practices by streamlining the committee process and bolstering the Leadership Committee's teamwork to guide the NCKF network.



MEMBER SPOTLIGHT: GEORGIA FAMILY CONNECTION PARTNERSHIP

Georgia Family Connection Partnership (GaFCP) is a public/private organization that works to improve conditions for Georgia's children and families. GaFCP connects local, regional, and state partners, and provides data and research to educate them about child and family well-being so they can make informed decisions.

GaFCP also supports a statewide network of 159 county collaborative organizations. These collaboratives bring together human service providers; family, community, education and business leaders; faith and civic-based organizations; local elected officials; and concerned citizens to address the challenges children and families face in their communities. The Partnership works with collaboratives to develop strategic plans that set goals and measure their improvement over time. Their goals focus on children being healthy, ready for and succeeding in school; stable, self-sufficient families; and strong communities.

GaFCP recently participated in a joint grant with *Voices for Georgia's Children* to develop a tool to provide a consistent, concise message that health coverage solutions do exist for the more than 300,000 uninsured children in Georgia. Part of that tool is a video these organizations produced to create awareness
