MEDICAID SAFETY NET ACT

In late April, the House of Representatives passed by a veto-proof margin (349-62) the bipartisan bill "Protecting the Medicaid Safety Net Act" (H.R. 5613). This is a major victory for those who provide services to Medicaid consumers as well as for those who receive those services. Medicaid directors and governors nationwide supported the passage of the Medicaid Safety Net Act. The next step will be for the Senate to take action.

The actions taken to reach out to Congressional representatives, governors and Medicaid directors by network members and other organizations nationwide ensures that the voice of the underserved is heard. We must continue to educate our communities to guarantee federal support for the Medicaid program.

WHAT'S UP WITH THE NETWORK (CONTINUED)

Leadership Committee: The Leadership Committee will meet for the second time May 28th and 29th to review last year's strategic plan and look ahead to the NCKF Network's future. We hope all members had an opportunity to review our operating principles and have a better idea on how to get involved, member expectations, how the network can provide support, resources, advocacy assistance and networking opportunities throughout the year.

Regional Convenings. The Education Committee hosted an informational teleconference in April regarding the four regional convenings that we will kick off this summer. We received interest and inquiries from multiple network members. The committee will review the interest forms after the May 5th deadline.

National Teleconference: The Education Committee will convene the next National Teleconference to focus on coverage efforts in tough fiscal and policy environments and how we move forward. In addition to national speakers, the committee will ask network members to share their state perspectives and policy outlooks.

MEMBER SPOTLIGHT: FAMILY & YOUTH COUNSELING AGENCY OF SOUTHWEST LOUISIANA

Family & Youth Counseling Agency of Southwest Louisiana is a non-profit, United Way and community supported agency that provides individual and family counseling services, business and industry support, and children's advocacy. Family & Youth has made great strides in demystifying the idea that LaCHIP is a program that is not for everyone by engaging in outreach to both professionals and families in their communities. Through their collaboration with other organizations in the Children & Families Action Network (CFAN), Family & Youth is able to connect with many families in Southwest LA, thus giving more children the chance to enroll in LaCHIP. Community events, such as the annual Family Festival, increase these opportunities to connect with families. Members of CFAN come together at the Family Festival to provide information about their agencies to more than 1,000 families each year. Children are entertained with hands-on activities while parents are educated about how to obtain the assistance they may need. This year there will be a greater focus on health-related information with representatives from LaCHIP in attendance.

Julio Galan, Executive Director of FYCA; David Duplechian, Associate Executive Director of FYCA; and Susan Poston, Program Coordinator for CFAN recommend this type of collaboration to other organizations that are looking for ways to enroll more children. Their experience has been that these collaborations are cost-effective, create stronger connections in the community, and create momentum in breaking down barriers to enrolling kids.
