# FEDERAL ISSUES

New CMS Guidance on CHIPRA Rules Regarding Coverage for Pregnant Women

On May 11th the Department of Health and Human Services, Centers for Medicare & Medicaid Services released guidance on CHIPRA rules regarding coverage for Pregnant women. Under CHIPRA states will have the option to provide health care coverage for uninsured, low-income pregnant women including in most cases, benefit during a 60-day postpartum period. In order to be eligible to receive enhance Federal Medicaid Assistance Payment (FMAP) for such expenditures including providing presumptive eligibility to pregnant women, states must meet specific criteria. In order to adopt any of the options states must submit a CHIP plan amendment.

#### State Health Access Program (SHAP) Grants

The State Health Access Program will provide \$75 million per year in grant funding for five years for states to provide the uninsured with access to affordable health insurance. The on-line application became available from the US Department of Health and Human Services Health Resources and Services Administration (HRSA) on April 21, 2009. The deadline for applications is June 16, 2009, at 8 pm EDT and the project award date is September 15, 2009. Only one application may be submitted for each state or territory. Only the Governor (or Governor's designee) may apply for a grant. Grants will be awarded competitively to approximately 10 to 15 States that have a health care access program initiative ready to implement within 12 months of the grant start date. Enacted in the 2009 Congressional Appropriations Bill (PL 111-8), grants will total \$2-4 million for targeted groups of uninsured and \$7-10 million for larger states or more comprehensive initiatives.

## Expanding Health Care Coverage: Proposals to Provide Affordable Coverage to All Americans

On May 11th the Senate Finance Committee Chairman Max Baucus (D-Mont.) and Ranking Member Chuck Grassley (R-Iowa) released policy options for expanding health care coverage to the 46 million Americans who are currently uninsured. It provides the framework and lays out some of the options for health reform: expansion of public health programs, individual market reform and a health insurance (Continued on page 3)

- 3. Offer a clearinghouse of resources.
- 4. Actively support the expansion of quality health care coverage.
- 5. Create greater public awareness about the issues.
- 6. Mobilize grassroots network of frontline providers and families.

"exchange," required individual and employer contributions to health coverage, a public health insurance option, and much more. On May 14<sup>th</sup> the Finance leaders walked through the options at a Committee meeting to solicit thoughts and ideas from members on the options for expanding coverage. The final policy options paper on financing health care reform will be released before the members meeting on that topic scheduled for May 20th.
