50 State Survey on Medicaid and CHIP Eligibility Rules, Enrollment and Renewal Procedures and Cost Sharing Released

On January 11, the Georgetown Center for Children and Families and the Kaiser Commission on Medicaid and the Uninsured released "Holding Steady, Looking Ahead," the latest 50 state survey of Medicaid and CHIP eligibility rules, enrollment and

renewal procedures, and cost sharing requirements. The survey found that over the past year, as the nation's attention was focused on the country's economic problems and the debate over the passage of broader health care reform, Medicaid and the Children's Health Insurance Program (CHIP) continued to play a vital role of providing coverage to millions of people who otherwise lack affordable coverage options. This report contains a wealth of information for those of you in states to have a better understanding of where your state stands in relation to what other states do in these areas and where you might improve or where you might be a trendsetter.
