### CMS Outreach Grant Applicant Teleconference

The third applicant's teleconference for the CHIPRA Cycle II outreach grants is scheduled for Thursday, March 24 from 4 to 5 p.m. Eastern Time. Despite efforts in recent years to enroll and retain children in health insurance, three out of four uninsured children remain eligible for, but not enrolled in Medicaid or CHIP. #### New Resources on the Importance of Medicaid

## What the ACA Says about Online Applications- New Resource from Families USA

The ACA requires that all states have a single, streamlined online application (in addition to in-person, telephonic and mail-in paper applications) for Medicaid, CHIP, and the health insurance exchange premium credits by 2014, which will make it easier for beneficiaries to apply for and enroll in the most appropriate coverage for them. This paper from Families USA details the online application requirements in the ACA, looks at where some states are currently, and looks ahead to future implementation of online applications.
