Notes: Children are defined as those under the age of 18 and low-income is defined as under 200% of the Federal Poverty Level (FPL). Data on poverty levels include only those individuals for whom the poverty status can be determined for the last year. Therefore, this population is slightly smaller than the total non-institutionalized population of the U.S. and estimates may differ slightly from estimates published in Georgetown CCF's brief, *Children's Health Insurance Rates in 2014*. Sources of coverage are not mutually exclusive; a person may have more than one type of coverage. Estimates have a 90% confidence interval.
