Kansas: Uninsured Parents Potentially Eligible for Medicaid Under the ACA¹



There are an estimated 4.7 million uninsured parents nationwide who will be eligible for Medicaid under the Affordable Care Act on January 1, 2014, who have a child who is currently enrolled in Medicaid/CHIP or an uninsured child who is eligible for Medicaid/CHIP but not enrolled. Forty-eight thousand, or one percent, of these parents live in Kansas. Below is a snapshot of the key demographic and socioeconomic characteristics of these parents in Kansas as compared to the United States.
