In this workshop, we will review the strategies available to connect children and their parents to affordability programs, including Medicaid, CHIP and advance premium tax credits. The reasons for states to maximize enrollment in Medicaid, CHIP and exchanges are many. Higher enrollment minimizes the potential for adverse selection in exchanges. Lower rates of uninsured reduce uncompensated care and unmet health needs. But most importantly, millions will gain access to more affordable health coverage, many for the very first time. This session will explore how outreach, navigators, and consumer assistance provided by exchanges and Medicaid agencies as well as expedited enrollment methods are all needed to get the job done.

Since HHS has determined that states will have a large role in selecting the essential health benefits under the ACA, state advocates have the opportunity

The ACA requires pediatric services, including dental and vision benefits, to be part of the essential benefit package, but how this requirement will be fulfilled remains to be determined in many states.
