Washington: Uninsured Parents Potentially Eligible for Medicaid Under the ACA¹



There are an estimated 4.7 million uninsured parents nationwide who will be eligible for Medicaid under the Affordable Care Act on January 1, 2014, who have a child who is currently enrolled in Medicaid/CHIP or an uninsured child who is eligible for Medicaid/CHIP but not enrolled. Eighty-nine thousand, or 1.9 percent, of these parents live in Washington. Below is a snapshot of the key demographic and socioeconomic characteristics of these parents in Washington as compared to the United States
